Commissioner Wallace called the meeting to order at 7:30 PM with a moment of silence for fallen first responders and those who serve in our armed forces around the world.

#### **Chiefs Report**

- -Reported 310 calls year to date.
- -The North Main Street Bridge is slated to be closed on June 1<sup>st</sup> for repairs. Staging of equipment and mutual aid responses are being considered. Access to Nazareth College may be through Golden Flyer Drive off French Road.

#### **Administrators Report**

- -Spring property maintenance programs are underway. Lawn damage due to snow plowing has been addressed
- -Work to update CCTV systems is ongoing, with equipment on order
- -Treasurer Clouser is working with Just Solutions to implement CCTV configurations. A monitor at station 1 that developed a defect is being replaced under warranty.
- -Recommended the execution of a renewal to the district EAP program.
- -Recommended pressure washing work at Station 2. Many areas need cleaning due to environmental accumulation
- -Problems with the older portion of the Corayvac system at station 2 have revealed that since it's in stallion in 1972, many parts may not be available. An update or replacement may be necessitated.

Commissioner Willard moved, seconded by Commissioner Whelan, that the board approve a two-year renewal the existing Employee Assistance Program at a cost of \$1,975.00 per year, and authorized the Chairman to execute the contract on behalf of the district.

Commissioner Cline moved, seconded by Commissioner Rickett, that the board approve pressure washing services at Station 2 to be performed by All Clean Power Washing at a cost of \$4,980.00.
