Chief's Report

- -Reported 387 Calls Year to date,

- -Water problem pump kits have been ordered
- -Recommended approval of operators for apparatus

Administrator's Report

- -Repairs to kitchen equipment at station 2 are being conducted
- -The repair or replacement of some HVAC equipment at station 2 is being evaluated.
- -A boy scout in search of an Eagle project will be referred to the town.
- -Additional new Station Attendants are being recruited.
- -Due to long lead times, work to procure a new chief's vehicle by year-end has begun.

Commissioner Lusk moved, seconded by Commissioner Schenkel, to declare as surplus equipment that is obsolete or beyond repair and is of no further value to the district:

13221: EMS suction unit, 11888 and 11889: Prosser pumps, and an inflatable water rescue boat.

- -The fire department has approved the financing of a rider to the district liability insurance policy.

-The project to repair the carriage house cupola has been completed. Compliments have been received as to the appearance.

Commissioner Lusk Report

- -An application has been submitted to the Village of Pittsford regarding the proposed resubdivision of properties adjacent to station 1. A village review will be held on July 10th.
- -Attorney Weishaar is preparing documentation to facilitate a possible sale of the 19 North Main Street property.
- -Proposed engaging a realtor to facilitate the sale of the 19 North Main Street property.

Commissioner Lusk moved, seconded by Commissioner Schenkel, to engage T. Peter Brizee, Realtor, to represent the fire district in certain real estate matters.

Commissioner Schenkel Report

-Due to construction, a long-time food vendor who has operated on North Main Street will be displaced. Commissioner Schenkel proposed an agreement to permit the food vendor to conduct his business on district property.

Commissioner Schenkel moved, seconded by Commissioner Khalil, to approve a Vending Agreement with Harladay Hots, Inc. to operate on district property.

Commissioner Whelan Report

- -A meeting with ISO was held to review the district ISO insurance classification. It is expected that the district will retain its current ISO Class 3 rating.
- -The budget planning process for 2025 is ongoing.

Commissioner Willard Report

-The EMS crisis in Monroe County will be the topic of an upcoming meeting of the county fire district officer's association. Concern has been expressed by many fire agencies that dispatching fire companies to compensate for the shortage of available ambulances will overtax fire departments. Chief Ryan echoed this concern and stated that he is not in favor of expanding the types of EMS calls Pittsford answers as this could place a strain on Pittsford firefighters.

Commissioner Wallace Report

-No report, absent.

- -Notification from the fire department of the acceptance of a new member
- -Notification from Oak Hill Country Club of the layoff of ninety-seven employees effective September 3rd.
- -Statement from Teitsworth Auctioneers of funds received for the sale of surplus district equipment.

Commissioner Khalil moved, seconded by Commissioner Cline, to approve the membership of Tyler Merrick, residing at 160 Sylvania Road, as a member of the Pittsford Fire Department pending completion of his district physical.
