THE PITTSFORD FIRE DISTRICT November 14, 2024

Regular Meeting

Present: Commissioners Cline, Khalil, , Schenkel, Wallace, Whelan, and Willard

Absent: Commissioner Lusk

Also present: Assistant Chief Cline and Treasurer Clouser

Commissioner Wallace called the meeting to order at 7:00 PM with the Pledge of Allegiance and a moment of silence for 9-11 victims, fallen first responders and men and women in the armed forces serving around the world.

Chief's Report

- -Reported 818 Calls Year to date,
- -A second alarm fire occurred on Line Street. The ATV responded to Honeoye Falls to assist in the rescue of a horse stuck in the mud.
- -Recommended approval of operators for apparatus
- -Mendon Fire District requested authorization to fill air bottles as a backup to their other resources.

Commissioner Wallace moved, seconded by Commissioner Cline, to approve operators for apparatus as they had successfully completed mandated training:

Engine 383 and 385: Firefighter Frazier

Engine 383: Firefighter Sorrells

The motion carried by an Aye vote of commissioners present.

Commissioner Wallace moved, seconded by Commissioner Willard, to authorize filling SCBA bottles for the Mendon Fire District on an as-needed basis.

The motion carried by an Aye vote of commissioners present.

Approval of Minutes

Commissioner Willard moved, seconded by Commissioner Schenkel, the board approved the minutes of the October 15th regular meeting as submitted,

The motion carried by an Aye vote of commissioners present. Commissioners Khalil and Whelan abstained as they were not present at that meeting.

Administrator's Report

- -Snowplowing Contract for 2024-25 Season: Following publishing and posting a Request for Proposals, one proposal was received by the district
- -The owner of a bulldozer which overturned on Clover Street agreed to reimburse the district for absorbent used by the fire department to mitigate a fuel spill.
- -Recommended approval of a renewal of a Cancer Coverage Insurance Policy. The renewal premium is slightly lower than the previous year.
- -Recruiting of station attendants is ongoing and current staff have received uniform items.
- -Efforts to classify station attendants with Civil Service are underway. In conjunction with that, formal performance evaluations will be conducted.
- -Recommended that an order be placed for a replacement chiefs' vehicle. It is expected to be available in the first quarter of 2025.

Commissioner Cline moved, seconded by Commissioner Khalil, the board awarded a contract for snowplowing to Tim Swagler Tree Service for the amounts stated in his proposal, with clarification that the cost of plowing 19 North Main Street will be at a per-trip cost of \$30.00.

Commissioner Cline moved, seconded by Commissioner Willard, the board authorized the renewal of a policy with New York State Firefighter Cancer Benefit Program at a cost of \$10.226.02.

Commissioner Schenkel moved, seconded by Commissioner Willard, the board authorized purchase of a 2025 Chevrolet Tahoe from DeNooyer Chevrolet as they were the lowest responsible bidder. The purchase amount is \$57,720.00. This purchase is made under the auspices of a bid established by a Franklin County contract.

Commissioner Cline Report

- -Recommended approval of a health screening program. The vendor will make a presentation to firefighters on November 25th.

Commissioner Cline moved, seconded by Commissioner Schenkel, The Chairman is authorized to execute a previously approved contract for health screening, pending review of legal counsel. *The motion carried by an Aye vote of commissioners present.*

Commissioner Cline moved, seconded by Commissioner Schenkel, The district will absorb the cost of health screening for individuals who have left fire department membership during a previous five-year period.

Commissioner Khalil moved, seconded by Commissioner Cline, to approve the application of Matthew Garber of 17 Kirklees Road as a member of the Pittsford Fire Department pending completion of his district physical.
