7:00 PM - Regular Meeting

Commissioner Wallace called the meeting to order at 7:00 PM with the Pledge of Allegiance and a moment of silence for fallen first responders and men and women in the armed forces serving around the world.

Cathy Perieira and Brian Rice, of Manning and Napier, presented a status report of the district Length of Service Award fund. They reported that the account is performing well and is adequately funded.

Sean Hucko, of the accounting firm of Stokes, Visca, Hucko and Verone presented the final 2024 audit of the district. He reported that no deficiencies were found in the accounts.

Chiefs' Report

- -Reported 159 calls year to date. Pittsford crews successfully revived a collegiate athlete at Nazareth University.
- -National fire incident reporting is transitioning from National Fire Incident Reports to a new format which will better provide fire statistics and program support. Training is currently ongoing. Firefighters Hinkle and Coleman are participating in the training.
- -Rescue 388 is out of service for repairs. Equipment has been relocated to pumpers and Squad 386. Brighton and Bushnell's Basin will respond on a mutual aid basis as needed.
- -Brighton will be filling in at station 1 on March 29th from 5:30 until 11:00 p.m.
- -Brighton has requested that Engine 385 be made available for evaluation as they are ordering new engines.
- -Evaluating Stryker AED devices as previously approved
- -Lieutenant Furber is working to evaluate replacement turnout gear as budgeted.

Commissioner Lusk moved, seconded by Commissioner Willard, the board approved sending Engine 385 to Brighton on April 3rd as part of their process to evaluate equipment. *The motion carried by an Aye vote of commissioners present.*

Administrator's Report

- -A new vehicle is expected to be in service soon. Presented quotes for acquisition and installation of emergency equipment
- -Repairs to the diesel storage tank at station 2 are expected to be completed soon
- -Continuing study of civil service compliance
- -Continuing to obtain quotes to replace the wooden fence along the bank property

Commissioner Khalil moved, seconded by Commissioner Willard, the board approved an amount not to exceed \$17,000.00 to equip a new vehicle.

The motion carried by an Aye vote of commissioners present, with the exception of Commissioner Cline, who abstained.

- -Reported on an MCFDOA meeting where the ongoing ambulance shortage was discussed.

About thirty percent of Pittsford Ambulance responses are to the Town of Brighton
